Presidents Report:

- Landbank had moved to 226 N Franklin Street
- Website: Updated inventory as well as Updated Minutes have been put on the website.
- The annual report for 2024 is close to finished.
- Met with Community Development and Urban Planning Committee on things landbank needs improve
- Met with the Audit Review Committee with Becky Vogel and they stated that the Land Bank Programs are administered accurately and efficiently Received \$100,000 from Discover Bank



- a \$800,000 grant from Longwood is in the works, Bud walked with There Dupont and the meeting went very well.
- Submitted application for Community Reinvestment Fund.
- Bank of America wants to do a check presentation on May 20th after we received \$250,000 from them over two years.
- The City Council wants a public hearing for Gibraltar.

Finance Committee Report:

- Hal wants to budget quarterly instead of monthly.
- We have the numbers and chart of accounts more organized and we need to fine tune what we are looking at.
- 80% of the money that comes in we have not much discretion, most money is restricted funds.
- We have \$1,538,000.00 in unrestricted funds.
- Hal recommends the Policies/ Procedures approval. If done properly these procedures should have us in good shape.
